#### **Market Demand Supports No-Smoking Policies**

Almost two-thirds (64%) of Ontarians living in multi-unit dwellings prefer smoke-free living, according to a 2006 survey commissioned by the former Ontario Tobacco-free Network, a provincial interagency network consisting of the Canadian Cancer Society, Ontario Division, the Heart and Stroke Foundation of Ontario and The Lung Association. Approximately 85% of Ontarians do not smoke, and over 80% of Ontario households already have policies prohibiting smoking indoors. There is currently a serious shortage of rental accommodation in Ontario for people who want or need to live smoke-free.

#### **Policy Will Be Applied Gradually**

By law, all current tenants of (insert housing corporation/company name) will be 'grandfathered' (exempted) for the duration of their tenancies until they choose to move out. This means that they, along with their visitors or guests, will continue to be permitted to smoke inside their rental units, on balconies or patios, as well as anywhere else on the property.

However, as of (enter date), all new tenants will be required to sign a tenancy agreement that includes a no-smoking clause. This means that new tenants and their visitors or guests will not be permitted to smoke tobacco in any of the rental units, on balconies or patios or anywhere else on the property. Existing residents are encouraged to voluntarily comply.

Tenants will be happy now because they won’t have to breathe second-hand smoke where they live,” said Pippa Beck of the Non-Smokers’ Rights Association. “In addition, property owners will have less maintenance, less expensive turnovers and fewer fire hazards to worry about.”
